NATURE OF THE AWARD

THE GREAT AUSTRALIAN RED IS A COMPETITION FOR ALL AUSTRALIAN CABERNET SHIRAZ AND SHIRAZ CABERNET BLENDS. PRODUCERS ARE INVITED TO ENTER BOTH PREMIUM AND CONSUMER-LEVEL PRODUCTS.

ELIGIBLE WINES

- 1. Only wines able to be labelled as Cabernet SHIRAZ OR SHIRAZ CABERNET (OR EQUIVALENT) ARE ELIGIBLE.
- 2. CABERNET SAUVIGNON AND SHIRAZ MUST EACH BE PRESENT IN THE BLEND IN PROPORTIONS NOT LESS THAN FIFTEEN PERCENT.
- 3. STRAIGHT VARIETAL SHIRAZ AND STRAIGHT VARIETAL CABERNET ARE NOT ELIGIBLE IN THE COMPETITION.
- 4. THE TOTAL PROPORTION OF CABERNET SAUVIGNON AND SHIRAZ TOGETHER MUST BE AT LEAST EIGHTY-FIVE PERCENT. THAT IS, NO OTHER VARIETAL OR COMBINATION OF VARIETIES MAY REPRESENT MORE THAN FIFTEEN PERCENT OF THE BLEND.
- 5. Only bottled wines may be submitted. UNBOTTLED SAMPLES ARE INELIGIBLE.
- 6. WINES OF ANY VINTAGE MAY BE SUBMITTED ON THE CONDITION THAT THEY ARE CURRENTLY AVAILABLE OR WILL BE AVAILABLE IN THE FUTURE.
- 7. The same wine may not be entered by more THAN ONE COMPANY.
- 8. There is no minimum volume requirement.

COMMERCIAL TITLE

ENTRANTS ARE REQUIRED TO SPECIFY COMMERCIAL TITLES (NAMES ON LABELS) OF ALL ENTRIES.
