# CONDITIONS OF ENTRY

## NATURE OF THE AWARD

THE GREAT AUSTRALIAN RED IS A COMPETITION FOR ALL AUSTRALIAN CABERNET SHIRAZ AND SHIRAZ CABERNET BLENDS. PRODUCERS ARE ENCOURAGED TO ENTER BOTH PREMIUM AND CONSUMER-LEVEL PRODUCTS.

## ELIGIBLE WINES

1. ONLY WINES ABLE TO BE LABELLED AS CABERNET SHIRAZ OR SHIRAZ CABERNET (OR EQUIVALENT) ARE ELIGIBLE.
2. CABERNET SAUVIGNON AND SHIRAZ MUST EACH BE PRESENT IN THE BLEND IN PROPORTIONS NOT LESS THAN FIFTEEN PERCENT.
3. STRAIGHT VARIETAL SHIRAZ AND STRAIGHT VARIETAL CABERNET ARE NOT ELIGIBLE IN THE COMPETITION.
4. THE TOTAL PROPORTION OF CABERNET SAUVIGNON AND SHIRAZ TOGETHER MUST BE AT LEAST EIGHTY-FIVE PERCENT. THAT IS, NO OTHER VARIETAL OR COMBINATION OF VARIETALS MAY REPRESENT MORE THAN FIFTEEN PERCENT OF THE BLEND.
5. ONLY BOTTLED WINES MAY BE SUBMITTED. UNBOTTLED SAMPLES ARE INELIGIBLE.
6. UNLABELLED BOTTLES MAY BE SUBMITTED WITH LAB LABELS.
7. WINES OF ANY VINTAGE MAY BE SUBMITTED ON THE CONDITION THAT THEY ARE CURRENTLY AVAILABLE OR WILL BE AVAILABLE IN THE FUTURE.
8. THE SAME WINE MAY NOT BE ENTERED BY MORE THAN ONE COMPANY.
9. THERE IS NO MINIMUM VOLUME REQUIREMENT.

## COMMERCIAL TITLE

ENTRANTS ARE REQUIRED TO SPECIFY COMMERCIAL TITLES (NAMES ON LABELS) OF ALL ENTRIES.
