NATURE OF THE AWARD

THE GREAT AUSTRALIAN RED IS A COMPETITION FOR ALL AUSTRALIAN CABERNET SHIRAZ AND SHIRAZ CABERNET BLENDS. PRODUCERS ARE ENCOURAGED TO ENTER BOTH PREMIUM AND CONSUMER-LEVEL PRODUCTS.

ELIGIBLE WINES

- 1. ONLY WINES ABLE TO BE LABELLED AS CABERNET SHIRAZ OR SHIRAZ CABERNET (OR EQUIVALENT) ARE ELIGIBLE.
- 2. CABERNET SAUVIGNON AND SHIRAZ MUST EACH BE PRESENT IN THE BLEND IN PROPORTIONS NOT LESS THAN FIFTEEN PERCENT.
- 3. STRAIGHT VARIETAL SHIRAZ AND STRAIGHT VARIETAL CABERNET ARE NOT ELIGIBLE IN THE COMPETITION.
- 4. The total proportion of Cabernet Sauvignon and Shiraz together must be at least eighty-five percent. That is, no other varietal or combination of varietals may represent more than fifteen percent of the blend.
- 5. ONLY BOTTLED WINES MAY BE SUBMITTED. UNBOTTLED SAMPLES ARE INELIGIBLE.
- 6. Unlabelled bottles may be submitted with lab labels.
- 7. WINES OF ANY VINTAGE MAY BE SUBMITTED ON THE CONDITION THAT THEY ARE CURRENTLY AVAILABLE OR WILL BE AVAILABLE IN THE FUTURE.
- 8. The same wine may not be entered by more than one company.
- 9. There is no minimum volume requirement.

COMMERCIAL TITLE

ENTRANTS ARE REQUIRED TO SPECIFY COMMERCIAL TITLES (NAMES ON LABELS) OF ALL ENTRIES.
